- 1. **Meeting Opening** –Mayor Clark opened the meeting at 7:04 p.m.
- 2. <u>Community Discussion</u> Village Trustees and officials met with the public and discussed items of interest. Some of the topics included: Zoning Law Amendment: Congregate Housing; Wastewater Treatment bonds; Village Band; Rental Property Inspection; New York Main Street Grant; Complete Streets Mini grant; Election Polling Sites; Village Website.

 - a. A motion was made and seconded by Trustees Bowden/Prophet to approve the minutes

- **c.** WWTP Digestor Cover \$600,000 Project Completion A motion was made and seconded by Trustees Dosch/Prophet to approve the completion of the USDA \$600,000 WWTP Digestor Cover Project. Motion passed 4-1.
- **d.** WWTP Improvements \$250,000 Bond Resolution The bond authorization for the project just closed was originally in the amount of \$800,000, and the Village completed it at \$600,000 in order to conduct a separate borrowing independent of the USDA process. A new independent bond authorization has been prepared for the remaining improvements necessary at the Wastewater Treatment Plant. **A motion was made** and seconded by Trustees Dosch/Bowden to choose a 6-year borrowing period for a new \$250,000 bond. Motion passed 5-0.
 - i. <u>Fiscal Services</u> A motion was made and seconded by Trustees Rasmussen/Dosch to accept the fiscal services proposal dated May 17, 2012 for the \$250,000 bond resolution. Motion passed 5-0.
- e. <u>Employee Handbook</u> A motion was made and seconded by Trustees Dosch/Rasmussen to revise the Employee Benefits Section 1b to remove the following exclusions: Articles 12, 19 and 20. Motion passed 5-0.
- **f.** Anti-Noise and Public Peace and Order Laws —A motion was made and seconded by Trustees Bowden/Prophet to set a public hearing at 7:15 p.m. on July 10, 2012 on changing the fee structure of these laws. Motion passed 5-0.
